Section 4. First Aid Measures

First Aid Measures for Accidental:

General Advice: If symptoms persist, call a physician. Do not breathe dust/fume/gas/mist/vapors/spray. Do not get in eyes, on skin, or on clothing.

Section 5. Fire Fighting Measures
